- **With a Renewable Energy Credit (REC) Contract for solar greater than 10kW or for any size wind, hydro, biomass or heat recovery, the generation system is required to have a separate meter or metering source to provide "Actual Production" of the system on a monthly basis.**
- **System shall not be energized, except for testing purposes, until state electrical inspection, an LPEA inspection, and a net meter is installed.**
