Do you have one of these?

Of course, if you're a residential member of LPEA, you probably don't have one of these, but this is what a commercial stand-by generator looks like. This is LPEA's back-up located on the Bodo Park campus. Yes, your electric cooperative is prepared to stay in power in the event of a major outage in the region.

"As we go into our traditionally coldest, stormiest and iciest month of the year – January – we want to remind everyone about generator safety," says Dan Harms, manager of rates, technology and energy policy. "A homeowner may have their lights go out and think 'Oh yeah, I have a generator in the shed I can use.' But remember, a generator should always be installed properly before use."

During power outages, some LPEA members do rely on stand-by generators to continue supply of electricity. For the safety of the electrical equipment as well as the line crews, generators MUST be installed with a "double throw disconnect switch." This isolates the generating system from the LPEA system. Merely opening your circuit breakers is not adequate.

"If a generator is connected improperly, it could back-feed our lines," says Harms who encourages that a qualified, licensed electrician always be used when sizing and installing any electrical equipment. "Even though your generator may only be 120V, if it back-feeds

through our transformer, the voltage is raised to 7,200V. This is an extremely dangerous situation to personnel who may be working on the power lines under the assumption that the lines are not energized."

In addition to putting lives at risk, when any damage is repaired and our Operations Department

restores the power throughout the LPEA system, power will immediately begin flowing back to your meter. If your generator is not disconnected from the LPEA system with the double throw switch, the two electricity

sources will interconnect – collide, if you will – causing serious damage and possible destruction of the stand-by generator as well as any equipment it was supplying. Fire is also a possibility.

Members with back-up generators are requested to review information at www.lpea.coop/outage/generator,

or call 970.247.5786. LPEA representatives can also assist members in advance of purchasing a stand-by generator.

"We definitely hope that winter storms won't impact distribution of electricity from LPEA," says Justin Talbot, manager of operations. "Our team is ready, maintenance has been done, but if we do experience what might be a long-term outage, please heed the generator safety."

"And ultimately, you can help us protect our linemen by letting us know if you have a generator," says CEO Mike Dreyspring. "The top priority for LPEA always will be safety."

Scholarships available to LPEA students

All high school seniors, including home school students, in LPEA's service territory who receive their electricity from LPEA are eligible to apply for the variety of college scholarship and awards available through the cooperative. Deadline for application is Mar. 1, 2017.

LPEA directly offers the LPEA Scholarship (four-year) and LPEA/John Voelker Memorial Scholarship (two-year), per LPEA Board of Directors policies No. 411 and 416, plus provides for additional affiliated rural electric scholarships/ awards offered by Tri-State Generation and Transmission and Basin Electric Power Cooperative.

Specifically, LPEA will award two, four-year scholarships (140 credit hours) for students attending any college or university beginning with the 2016-2017 academic year. LPEA will cover tuition, books and fees, up to \$28,000 over four years, given that the students maintain minimum qualifications.

The LPEA/John Voelker Memorial Scholarship recognizes two students attending accredited vocational schools, technical schools or junior college. This two-year scholarship covers fees, books, tools and supplies up to \$10,000 over two years, per student.

Funds for the LPEA and LPEA/John Voelker Memorial Scholarships come from LPEA's unclaimed Capital Credits. Each year, LPEA endeavors to find "missing" members who are due a share of retired Capital Credits. Those funds unable to be returned to members are then put back into the community – in this case, into college scholarships.

LPEA supports training and educating local young people for positions they may ultimately secure at a rural electric cooperative, though this is not a requirement of the scholarships. Rural electric cooperatives are known nationally to provide stable employment, livable wages and solid benefit packages. LPEA is no exception and, with 110 employees, it exists as one of the more significant employers in the region.

"We were able to fill the needs of 25 Angel requests at the Durango Mall, fill five toy needs from the Toy Tree at Walmart, and help a young family from Needham Elementary currently experiencing difficult times," says Jeannie Bennett who coordinated the shopping activities.

On Dec. 14, the co-op hosted the Stuff the Kettle Green Chili Lunch supporting the Salvation Army. Food donations came from Bart's Deli and Sunnyside Meats, though LPEA staff baked combread and dozens of desserts. Q: I'm hearing the acronym "DG" referenced a lot these days. Could you explain what that means? A: "DG" stands for "distributed generation," as opposed to "centralized generation." Very basically, distributed generation is an approach that employs small-scale technologies to produce electricity in close proximity to the end users of power. DG often consists of modular (and often renewable-energy) generators, in contrast to the use of a few large-scale generating stations located far from load centers (for example, LPEA's primary (centralized) power supplier Tri-State generates power we use outside of LPEA's service territory). DG systems essentially provide power to customers with little reliance on the distribution and transmission grid. The current model for electricity generation and distribution in the United States is dominated by centralized power plants, though interest in DG is growing in popularity.
