# **REVIEW OF POLICY 112**

Attorney Smith addressed a proposed revision to <u>Policy 112</u>, Section II., C, 1 (Procedures for Introducing Bylaw Amendments <u>Petition form for LPEA Bylaw Amendment</u>). A recent amendment to <u>Article XV</u> of the bylaws changed the deadline for petitions for member-initiated bylaw amendments from 45 days to 60 days prior to the meeting of members. There were no other requested changes, and this was accepted by unanimous consent.
