LPEA Bylaws – Article III, Section 2 – Qualifications and Tenure (page 10)

In order to be eligible to become or remain a director of the cooperative a person shall:

- a. be a member of the cooperative for at least one year immediately prior to becoming a director,
- b. be a bona fide resident of the person's director district for at least one-hundred twenty days prior to becoming a director, which means that the person must be a permanent occupant receiving electric service from the cooperative at the person's primary residential abode,
- c. not be employed by or have a spouse or children employed by the cooperative in any position.

All candidates running for election to the board of directors shall disclose monetary and inkind contributions to the director's campaign. The board of directors shall establish a policy setting forth rules for reporting campaign contributions consistent with this provision.

Procedure for Filing for a Board Position:

- Obtain a Petition and Director Qualification Affidavit from the LPEA office in Durango or Pagosa Springs; or via LPEA website www.lpea.coop.
- Candidate must meet the qualifications set forth in Art. III, Sec. 2 of the Bylaws, as stated above.
- Petitions must contain fifteen (15) or more signatures from co-op members in candidate's district.
- Director Qualification Affidavit signed & returned.
- Director Candidate Disclosure Form (Policy 107); accessible via LPEA website www.lpea.coop.

Deadlines:

- Return Petitions, Candidate Profile and Director Qualification Affidavit by 1:00 p.m. on Monday, March 4, 2019.
- Director Candidate Disclosure <u>Interim Reporting</u> must be submitted <u>No earlier than April 17, 2019; No later than April 22, 2019</u>.
- Director Candidate Disclosure <u>Final Reporting</u> must be submitted <u>No later than</u> <u>May 15,</u> 2019.
