


2021 Board Director Candidate Packet

Thank you for your interest in running for a seat on the La Plata Electric Association, Inc. (LPEA) Board of Directors. In accordance with our <u>Bylaws</u>, one-third of LPEA's <u>Board of Directors</u> seats are up for election annually, one in each voting district.

Directors are elected for three-year terms. Incumbent directors up for re-election in 2021 are:

- District 1 Archuleta County: Kirsten Skeehan
- District 2 South and West La Plata County: Kohler McInnis
- District 3 City of Durango: Britt Bassett
- District 4 North and East La Plata County: Tim Wheeler



To be eligible to run for the LPEA Board of Directors, candidates must:

- be a member of LPEA for at least one year immediately prior to becoming a director;
- be a bona fide resident of the district you plan to represent for at least 120 days prior to becoming a director and;
- not be employed by, or have a spouse or child employed by, LPEA in any position.

2021 Election Timeline

- February 17, 2021: Board Director Candidate Packets available on LPEA's website
- May 3, 2021 at 1 p.m.: Initial candidate materials due to LPEA
- May 17, 2021: Ballots mailed to all LPEA members
- June 16, 2021 at 4 p.m.: Ballots due



- June 17, 2021: Partial, virtual Annual Meeting to announce election results
- June 21, 2021: New Board Member Orientation
- June 22, July 27, August 24, September 21, 2021: New Director LPEA Department Orientations (dates and details of orientations are subject to change).

Procedures and Deadlines

To be deemed an eligible candidate you must:

- Meet the eligibility requirements as outlined above.
- Complete and return the Candidate Profile, Photo, Petition with 15+ signatures, and Director Qualification Affidavit by 1:00 p.m. on Monday, May 3, 2021.
- If you wish to receive a member mailing list for your district, or other available items as referenced in <u>Policy 108</u>, you must complete the Request to Inspect or Copy Corporate Records form and associated Non-Disclosure Agreement and Affidavit forms by **1:00 p.m. on Monday, May 3, 2021**.*
- Submit the Director Candidate Disclosure Interim Reporting form **no earlier than June** 2, 2021 and no later than June 7, 2021.
- Submit the Director Candidate Disclosure Final Reporting form **no later than June 27**, **2021**.

Candidates who are verified as eligible, and who have completed all required materials by the listed deadlines, will be added to the official ballot.

*All candidates will be notified if additional items have been requested by a candidate(s) and will be afforded the same opportunity to obtain the requested items.

LPEA Board of Director General Duties and Responsibilities

The Board of Directors of LPEA is established by the LPEA Bylaws. The board meet at least monthly, and more frequently when determined by the action of the board.



The board sets strategic direction and establishes policy. It is responsible for hiring and evaluating the CEO, and for developing and approving the Mission and Vision statements and Strategic Plan. The CEO is responsible for directing staff and carrying out the will of the board. The staff is responsible for carrying out the business of the cooperative in close consultation with the CEO. The LPEA Bylaws and board policies outlining board and CEO duties and responsibilities can be viewed at <u>lpea.coop/lpea-policies-and-bylaws</u>.

The LPEA Board of Directors is a governing board with two primary roles: to support the success of the cooperative and to protect public interest through examination and monitoring of cooperative information. The board has three essential duties:

- 1. Duty of Care Exercise the same amount of care, caution, and common sense as any prudent person would in carrying out responsibilities to the organization.
- 2. Duty of Obedience Comply with all federal, state, and local statutes and laws. Be faithful to the organization's Mission, and abide by the bylaws, policies, rules, and regulations as adopted by the Board of Directors.
- 3. Duty of Loyalty As a director of the cooperative, you have a fiduciary role as a director, and that means in any conflict, you must put the interests of the cooperative above your own interests.

Time Commitment

LPEA Directors are expected to attend regular board meetings which typically take place from 9:00 a.m. to 5:00 p.m., on the third Wednesday of every month; as well as, Committee of the Whole meetings as set by the Board of Directors, from time to time, from 9:00 a.m. to 2:00 p.m. on the Monday prior to the Wednesday board meeting.

There are various board committees and other board commitments, for example, the Finance and Audit Committee, the Broadband Committee, and the Colorado Rural Electric Association, etc. Directors may participate as a committee member or as a guest.

A director can expect to spend an average of 7.25 hours per week preparing, studying, and serving on the board (based on 2017 IRS Form 990), and may attend up to 10 days of board approved education and/or training per year. Director training and certification courses are available through the Colorado Rural Electrical Association and the National Rural Electric Cooperative Association.

This summary of duties and responsibilities is neither exhaustive, nor representative of all circumstances under which the board performs its duties. Newly elected directors will receive an orientation with more details by the cooperative CEO, Attorney, Board President, and staff.
