## **APPROVAL OF AGENDA**

## APPROVAL OF FEBRUARY 7, 2019 PSC MEETING MINUTES

Committee Chairman Bassett addressed the February 7, 2019 PSC meeting minutes. Committee Member McInnis noted a grammatical modification.

# COMMITTEE DISCUSSION AND POSSIBLE ACTION

**UPDATE ON CONSULTANT PROJECTS** – Caitlyn Liotiris of Energy Strategies reported that she was working on building the portfolios and calculating the expected costs and how they change over time, including incorporating additional carbon-free resources for the future. Liotiris will coordinate with the Enchantment-Rio Energy consultants on production cost modelling for various wholesale energy price scenarios. Ed Reyes and Eddie Padilla of Enchantment-Rio Energy will push out an RFI in early March to see what the market is bringing. Discussion ensued on Tri-State's use of deferred Revenue and Debt to keep rates down, possible requirements to utilize LPEA's WAPA allocation, and transmission rates.

Draft deliverables from the consultants are now due the Tuesday before the scheduled dry runs.. In preparation for the formal executive session presentation to the LPEA Board on April 17, Liotiris will run through the contract valuation presentation on March 21, and Padilla-Reyes will run through the alternative power supply presentation on March 28 in executive session with the PSC. General reports from the consultants will be provided for the public.

**REVIEW OF WAPA LOVELAND AND OTHER MEETINGS** – PSC members discussed information gathered during a very productive meeting with the Western Area Power Association on February 13 in Loveland, Colorado about WAPA's network balancing capabilities.

**PSC BUDGET REVIEW** – Committee members discussed the budget status.

**FUTURE MEETINGS** – Committee Chairman Bassett confirmed upcoming PSC meetings will take place March 21, and 28.
