# EXECUTIVE SESSION: VENDOR CAPABILITY PRESENTATION AND AFFILIATE PRESENTATION

### **REVIEW OF COLORADO SB19-107**

CEO Dreyspring presented an overview of Colorado Senate Bill 2019-107 Broadband Infrastructure Installation. The bill, which becomes effective August 2, 2019, attempts to reduce

infrastructure costs by allowing commercial use of unlit fiber and electric transmission lines to deliver broadband into unserved and underserved communities, and potentially reducing the costs and time with the commercial lighting of broadband fiber. Dreyspring discussed applications, prohibitions, notice requirements to property owners, claim restrictions, and other details. LPEA is looking for certainty on how to apply the bill and will continue discussions during upcoming Board meetings. Dan Harms will present a strategic approach to SB2019-107 and communication plan during the Capital Project Budget Cycle.

## **GOOGLE DOCS TRAINING**

Dan Harms advised the Board of Directors on utilization of Google Docs and took questions.

TRI-STATE DIRECTOR REPORT - Director Skeehan touched on recent developments at Tri-State to move toward FERC regulation; and the decision to decline a proposal by Guzman Energy to purchase Tri-State coal assets, close the facilities, and provide an inexpensive mix of renewable energy sources back to Tri-State.
